GOAL 4: Enhance Access to Local Data:

• MiPhy –B.Hartl shared that the impact of obtaining and using local data is critical. The MiPhy is an online student health survey offered by the Michigan's Department of Education and Health and Human resources. MiPhy provides results on health risk behaviors. MiPhy focuses on 7-11 graders; it's very important to encourage schools to 1) participate in the confidential survey, and then 2) use the data. Among some of the interesting findings are that regular cigarette use is down, but e-cigarette use is up. Brain spoke of a call-to-action letter and invited all Coalition Members to participate in encouraging schools to participate in MiPhy. Deadline to participate is May 30, 2018. The county report will be published in mid to late July 2018.

GOAL 5: Expand Coalition Capacity Through Partnerships:

- KCPC Committee Updates & Breakouts N. Kimble & B. Hartl explained the landscape to engage, sustain and mobilize the community around the issues of SUD prevention in Kent County. This effort will include the involvement of the following KCPC Committees:
 - Community Engagements A Lunch and Learn is underway from a planning standpoint. The group continues to flush out event details regarding format, content, and presenters. At the time of reporting the Event date is TBD.
 - Data Committee Given the upcoming Ballot issue pertaining to recreational marijuana in Michigan, the group decided to devote its time in the next several months to this effort, and to "pause" efforts surrounding Better Drinking Culture –collaboration with organizations with same goals. Some of the discussion included developing a social media campaign, at least initially, that would arm voters with accurate information, while also acting as "myth busters."
