Abstract: The 2019 Medical Marijuana Operation and Oversight Grant (MMOOG), from the Michigan Department of Licensing and Regulatory Affairs, Bureau of Medical Marijuana Regulation, is a grant to be used for education, communication and outreach regarding the Michigan Medical Marijuana Act, 2008. The Health Department has partnered with the City of Grand Rapids and the Kent Intermediate School District to develop two separate educational campaigns with all activities to be completed by September 15, 2019.
